The IQAC meeting was held on 10th December 2018 to discuss the following matters:

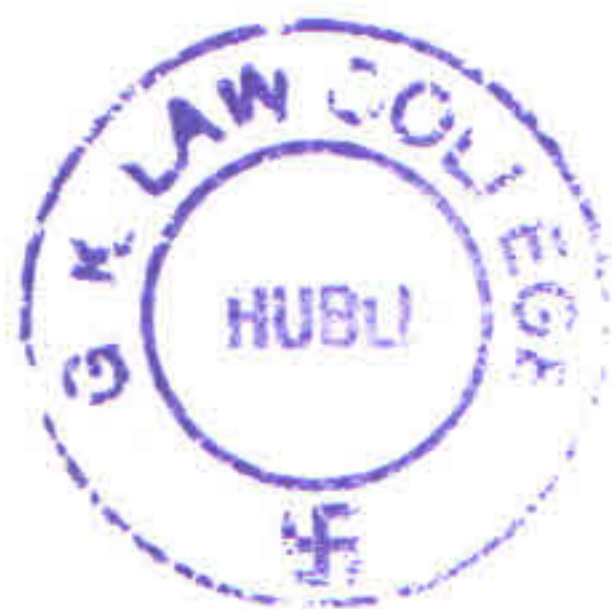
